Membership in the FSC is voluntary and may be terminated at any time by written resignation of the member or for cause by the Executive Board. Information contained on this form is used exclusively by the FSC to more effectively plan and organise its activities. Disclosure is voluntary; however, failure to provide this information may interfere with the provision and quality of services and activities provided to you.

Resignation, Removal: A member may resign as of the end of each fiscal year by filing a written resignation with the Secretary of the Association. The Executive Board may suspend a member for cause and especially for the following reasons:

- (a) Non-payment of the annual membership fee by 31st August of the new fiscal year.
- (b) Substantial violations of these Statutes.
